The owner of the property located at _____, Plat _____, Lot _____, hereby makes application to connect said property with the public sewer/water.

In consideration of the granting of this permit, the undersigned owner/contractor agrees to the following:

1. To strictly conform to all existing ordinances, rules and regulations, and to all ordinances, rules and regulations relating to the use of the public sewers/water and the making and using of all connections with said sewer/water, which may hereafter be enacted by the Town Council or the Town Engineer and approved by the Town Council.
2. That no claim for damages shall be made against the Town of Narragansett.
3. The Town does not guarantee the existence and/or location of any sewer/water main and/or connection.
4. That the Town Engineer or his/her duly authorized representative shall have access at all reasonable hours to the premises to see that all ordinances, rules and regulations relating to the public sewers/water and all connections therewith are being complied with.
5. All connections shall be of such size and material, and laid to such grade and depth as required in the ordinances, standard details, specifications, rules, and regulations relating to use of public sewers/water.
6. All work of making connections shall be under the supervision of the Town Engineer, or his/her duly authorized representative.
7. All excavation and repair work necessary or required shall conform to all ordinances, standard details, specifications, rules, and regulations pertaining to such right-of-way.
8. That plans and specifications for the proposed building sewer/water are to be attached hereto by the applicant.
9. To maintain the building sewer/water at no expense to the Town.
10. To notify the Wastewater Division at least two (2) working days prior to the time the building sewer/water is ready for inspection and connection to the public sewer/water, but before any portion of the work is covered.
11. Return the "Drain Layer's Return" to the Wastewater/Water Division Office with the appropriate signature of the Town Engineer or his/her agent certifying the job has been inspected, and completed in accordance with the requirements of the ordinance with detailed as-built information.
12. Obtain the necessary road cut permit(s) from the Town of Narragansett Department of Public Works and/or RIDOT as applicable. Note that a Town road cut permit is required for any work in a Town right-of-way. Where special pavement restoration techniques, including but not limited to infra-red patching, are required by either the Town pursuant to Chapter 17 or RIDOT, the actual cost of said pavement restoration, including any permit fees, shall be the responsibility of the applicant.
13. To install a backflow preventer after meter on new and/or relocated water services.

14. All expenses incurred with this project are the responsibility of the property owner.

15. All repair work to the public right-of-way, necessitated by this excavation, SHALL BE THE SOLE RESPONSIBILITY OF THE UNDERSIGNED CONTRACTOR. CONTRACTOR MUST BE A LICENSED DRAIN LAYER OR A MASTER PLUMBER
