Conduct of Meeting (School Committee Bylaws – Policy Book Section I.C) The conduct of the meetings shall be in accordance with the laws of the State relating to education and the rules of parliamentary practice as laid down in Robert Rules of Order – Revised. In order to ensure greater citizen participation for continuous, constructive dialogue in school committee meetings, the following procedure will be utilized:

1. An open forum of no more than thirty (30) minutes (3 minutes per speaker) will be offered at the beginning of each month's regularly scheduled meeting. The School Committee will permit people to ask questions or make comments relating to items both not on the agenda and items on the agenda. It will be understood that the School Committee members will just hear from the public during open forum and will be unable to respond in any collective voice to comments.
2. Questions and comments will be permitted during the time the Committee is conducting business. Such questions and comments must be germane to the issue being discussed. Such questions and comments will only be permitted when an official motion is being discussed and deliberated. Such questions and comments will only be allowed after all Committee members have had an opportunity to ask questions and make comments concerning the motion under discussion.
3. People giving reports should be questioned only by the School Committee and not by people in attendance.
