

# South Pavilion Locker Policy

## TOWN COUNCIL POLICY REGARDING LEASING OF SOUTH PAVILION LOCKERS AT THE NARRAGANSETT TOWN BEACH

Effective as of December 2, 2024, all new rental agreements will be for a maximum period of 5 years. At the end of the 5-year period the lessee's name may be added again to the waitlist. All residents/taxpayers who have leased a facility in 2024 and prior will continue to renew their lease until such time as they relinquish their facility. Should the current lessee change facilities, from a South Pavilion Locker to a North Pavilion Changing Room for example, the new lease will be in effect for a maximum of 5 years.

The Parks and Recreation Department shall maintain a waiting list for Cabanas, North Pavilion Changing Rooms and South Pavilion Lockers. All existing applications on file shall remain on file, containing only one name. The individual named must be a resident of Narragansett or own property and pay real estate property taxes of at least \$800.00 or more to the Town of Narragansett.

The waiting list shall be made available in the Town Clerk's office for public inspection and shall be updated quarterly and posted on the Town of Narragansett website by the Parks and Recreation Department. Annually the Parks and Recreation Department shall be required to verify that all lessees of Cabanas, North Pavilion Changing Rooms and South Pavilion Lockers meet the qualifications contained herein and, in addition, shall be required to verify that the top ten positions on each waiting list be verified to ensure that the individuals meet the qualifications contained herein.

### Definition of Key Terms

**Principal Lessee** - The person who leases the facility for the summer season and is responsible for all payment due for the facility.

**Pass Holder** – The person whom the principal lessee has provided a facility pass to for the summer season. These passes are non-transferable.

**Adult** - Any person 18 years of age or older.

**Youth** - Any person 12-17 years of age.

**Seniors** - Any person 62 or older.

### South Pavilion Locker Admission Policy

- o Entrance into the South Pavilion Locker area will be permitted only to those with the proper facility pass or guests who are accompanied by a facility pass holder.
- o For security purposes facility holders are asked to keep their units locked when they are not in the immediate area and to secure their unit before leaving for the day.
- o Passes transferred to an unregistered individual or used in any fraudulent manner will be confiscated and not replaced.

- The misuse of passes may impact your eligibility to renew in future years.
- Under no circumstances will anyone be allowed into the locker area without the proper facility pass.

### South Pavilion Resident/Taxpayer Rate

#### South Pavilion Pass Holder Policy

- South Pavilion Locker rate: \$420.00
- The Principal Lessee receives a photo ID facility pass.
- Three facility passes are for guests of the Principal Lessee.
- You are allowed to switch out TWO photo ID facility passes for two facility transferable passes.
- Lost or stolen photo ID facility passes may be replaced for a \$50 fee.
- Lost or stolen transferable facility passes may be replaced for a \$100 fee.

#### South Pavilion Resident/Taxpayer Locker Parking Policy / 2018 to Present

- One (1) parking pass per facility will be issued to the Principal Lessee. The **name and address on the registration must match the Principal Lessee.**
- Parking is available on a first-come, first-served basis in the South, North and West Parking Lots for **resident/taxpayer** South Pavilion lessees.
- Lost or stolen parking passes may be replaced for a \$100 fee.

#### South Pavilion Resident/Taxpayer Locker Parking Policy / 2017 and Prior

- One (1) parking pass per facility will be issued to the Principal Lessee. The **name and address on the registration must match the Principal Lessee.**
- Parking is available on a first-come, first-served basis in the South, North and West Parking Lot for **resident/taxpayer** South Pavilion lessees.
- A second parking pass may be purchased for a nonresident guest #1 of the Principal Lessee for an additional \$100 fee. **The name and address on the registration must match the guest #1.**
- The second parking pass is only issued to guest #1 with a photo ID facility pass. It cannot go with a transferable pass.
- **All nonresident South Pavilion guest #1 with parking passes are required to park in the South Lot.** The seasonal facility parking pass will have the following designation: **“NRS” (NonResident South).**
- Lost or stolen parking passes may be replaced for a \$100 fee.
