GENERAL INFORMATION & PROVISIONS REGARDING ALARM PERMITS

**** BURGLAR ALARM PERMIT FEE IS \$20.00 PER YEAR. - As per ordinance, Section 38-71 (CHECK OR MONEY ORDER ONLY --PLEASE MAKE CHECKS PAYABLE TO THE TOWN OF NARRAGANSETT).**

** ALL ALARMED LOCATIONS MUST SUBMIT AN ALARM PERMIT APPLICATION & FEE PER TOWN ORDINANCE. – SEE ordinance, Section 38-71 relating to alarm systems.

** RESPONSIBILITY OF PERMIT APPLICANT – It is the responsibility of the permit holder to update any or all information contained herein as it pertains to an alarmed location or reasons per ordinance for which this permit has been issued.

** FEE FOR FALSE ALARMS – A fee for false alarms over three (3) per year may be imposed as provided by Section 38-86 of the town ordinance of \$10.00 for each false alarm. Four (4) or more false alarms may constitute grounds for revocation or suspension of this permit, subject to the provisions of Section 10 of the town ordinance.

** A COPY OF THE ORDINANCE THAT GOVERNS THE ISSUE OF THIS PERMIT MAY BE OBTAINED AT THE NARRAGANSETT TOWN HALL 25 FIFTH AVE. NARRAGANSETT, RI 02882 DURING REGULAR BUSINESS HOURS.
